- I. Utility Supervisor Report Dave Houghtelling reported oil has been changed in the generators. The cost of this is around \$15,000.00 per year. The city has applied for a waste water grant from Senator Fisher. Greg has been checking bearings at the sewer plant. Street sweeper is currently in town. The city would like to get rid of the easy go and the golf course has shown an interest.
- J. City Clerk/Treasurer Report Kandra Kinne reported the audit was submitted to the state on March 31, 2023. Then city council was given the audit report and Kandra Kinne went through the audit report and ask if the council had any questions. She urged the council to review capital assets and long-term debt. She asked the city council if they would like the auditors in attendance to review the audit. Council did not feel that there was a need. The only findings were a deficiency in internal controls. The city receives this deficiency due to the number of staffing. There is not enough staff to perform each individual job and duties overlap. Vernita Saylor stated the motion, seconded by Jeff Ommert to approve the audit report. AN ORDINANCE AMENDING CHAPTER 3, ARTICLE 3, SECTION 3-303; FOWLS; WRITTEN PERMISSION, LIMIT NUMBER; REPEALING ALL ORDINANCES IN CONFLICT HERE WITH; ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDNAINED GBY THE MAYOR AND CITY COUNCIL OF THE CITY OF CAMBRIDGE, FURNAS COUNTY, NEBRASKA THAT:

Chapter 3, Article 3, Section 3-303 Fowls; Written Permission; Limit Number; shall be amended and added as follows:
