## City of Cambridge Regular City Council Meeting Monday November 6, 2017 6:30 P.M.

Pursuant to notice published in the Cambridge Clarion, Thursday October 26, 2017, and posted in the Cambridge City Office, the Cambridge City Council met for regular meeting convening at 6:30 P.M. Present were Mayor Mark Harpst, City Council Members Derek Raburn, Tony Groshong, Vernita Saylor and Jeff Ommert. City Council Tom McCarville entered the meeting at 6:35 P.M. City Staff present were Utility Supervisor David Houghtelling, City Clerk/Treasurer Kandra Kinne, Economic Development Director Diane Henderson and City Attorney Tom Patterson. Judy McCune was present for the Cobblestone Inn and Suites and Keith Luedders. Mayor Harpst opened the meeting with the Pledge of Allegiance. Mayor Harpst announced the open meeting law is posted on the east wall of the meeting room and available for public inspection.

City Council Member Appointment – Mayor Harpst presented the appointment of Keith Luedders to replace Jo Fuller, who has resigned from Ward III. Derek Raburn stated the motion, seconded by Jeff Ommert, to approve the appointment of Keith Luedders to the City Council in Ward III, to replace Jo Fuller who has resigned. On roll call vote Derek Raburn, Jeff Ommert, Tony Groshong and Vernita Saylor voted yes, none voted no and Tom McCarville was absent and not voting. Motion carried unanimously by City Council Members present. Keith Luedders took the Oath of Office as annexed to these minutes.

Cemetery Board Appointment – Mayor Harpst presented the appointment of John McLeod to the Cemetery Board. Vernita Saylor stated the motion, seconded by Tony Groshong, to approve the appointment of John McLeod to the Cambridge Cemetery Advisory Board. On roll call vote Keith Luedders, Jeff Ommert, Tony Groshong, Vernita Saylor, Tom McCarville and Derek Raburn voted yes, none voted no. Motion carried unanimously.

Public Hearing – Cobblestone Hotel – Special Designated Liquor Permits. Mayor Harpst opened the public hearing at 6:37 P.M. Judy McCune was present for the Cobblestone Inn and Suites. Judy explained that she will be hosting a wine tasting on December 2, 2017 and a Holiday Event on December 29, 2017. There were no other public comments and the public hearing closed at 6:40 P.M. Jeff Ommert stated the motion, seconded by Vernita Saylor, to approve a special designated liquor permit for Saturday December 2, 2017 at the Cobblestone Inn and Suites at 41502 Harvest Drive. On roll call vote Jeff Ommert, Tony Groshong, Vernita Saylor, Tom McCarville, Derek Raburn and Keith Luedders voted yes, none voted no. Motion carried unanimously. Vernita Saylor stated the motion, seconded by Tom McCarville, to approve a Special Designated Liquor Permit for Saturday December 29, 2017 at the Cobblestone Inn and Suites at 41502 Harvest Drive. On roll call vote Tony Groshong, Vernita Saylor, Tom McCarville, Derek Raburn, Keith Luedders and Jeff Ommert, voted yes, none voted no. Motion carried unanimously. Judy McCune reported Nebraska Life will be coming to Cambridge in March to do a story.

Ward Redistricting Ordinance. Kandra presented an ordinance to redistrict Wards I, II and III within the City limits of Cambridge. Kandra prepared a report showing population by Wards from the last census.

Kandra said that other options could require going to a vote to change the makeup of the wards or go to election at large. Vernita Saylor stated the motion, seconded by Tony Groshong, to approve the first reading of Ordinance No. 750 entitled "AN ORDINANCE AMENDING CHAPTER 1, ARTICLE 1-803 ENTITLED "ELECTIONS; VOTER EQUALIFICATIONS; SPECIFICALLY TO ESTABLISH WARDS WITHIN THE CITY LIMITS OF THE CITY OF CAMBRIDGE; TO REPEAL CONFLICTING ORDINANCES AND SECTIONS AND DIRECT THE PUBLICATION OF THIS ORDINANCE AND TO PROVIDE AN EFFECTIVE DATE. On roll call vote Vernita Saylor, Tom McCarville, Derek Raburn, Keith Luedders, Jeff Ommert and Tony Groshong, voted yes, none voted no. Motion carried unanimously.

Housing Rehab – Contract Payment. Mayor Harpst presented the payment of \$500.00 for Hayes Construction, on project CAM-HR-13. Vernita Saylor stated the motion, seconded by Tony Groshong, to approve Housing Rehab contract contractor payment CAM-HR-13 for \$500.00. On roll call vote Tom McCarville, Derek Raburn, Keith Luedders, Jeff Ommert, Tony Groshong and Vernita Saylor voted yes, none voted no. Motion carried unanimously.

Tom McCarville left the meeting at 7:00 P.M.

Economic Development Report – Diane Henderson discussed the downtown center plan to sell the building and said she is working on an offer. Tom Patterson recommended advertising for 4 more weeks and declare the property surplus. The City Council could accept sealed bids. Derek Raburn stated the motion, seconded by Tony Groshong, to Declare surplus the downtown center, 702 Patterson Street, and sale by sealed bid on Monday November 27, 2017. On roll call vote Derek Raburn, Keith Luedders, Jeff Ommert, Tony Groshong and Vernita Saylor voted yes, none voted no, Tom McCarville was absent and not voting. Motion carried unanimously by City Council Members present. Diane reported the Economic Development Board is applying to the Perkins Foundation for funding for projects. Lifetime Eye care is planning to locate in Cambridge as soon as a building is available next summer. The Website is moving forward and will have more information. The Economic Development Board is in discussion about an election for the 20/20 plan. Diane is in discussion with several contacts and has interest in about 10 lots in Harvest Meadows. Two lots will be under contract. Vantage Point Homes of Lincoln is interested in building a spec home in Harvest Meadows. Diane said the Economic Development plan to give incentives to build houses has help with the interest in Harvest Meadows. McCook Community College Merchandising Assistance will be in Cambridge assisting local businesses. The Economic Development Board will meet on November 8<sup>th</sup>.

Utility Supervisor Report – Dave Houghtelling presented a proposal to purchase a pickup to replace the 2006 GMC Sierra regular cab pickup. Vernita Saylor stated the motion, seconded by Jeff Ommert, to approve the purchase of a 2018 Silverado pickup from Faw Motor Company with trade of the 2006 GMC Sierra Regular Cab pickup for \$21,000.00. On roll call vote Jeff Ommert, Tony Groshong, Vernita Saylor, Derek Raburn and Keith Luedders voted yes, none voted no, and Tom McCarville was absent and not voting. Motion carried unanimously by City Council Members present. Dave discussed the installation of a breaker at the North substation. The Breaker has been purchased for \$15,852.05 and is on site for installation. Olsson Associates worked with Dave to bid the project. Dave received two proposals one from IPC for \$33,826.00 and one from IES Commercial, Inc. for \$29,810.00. Vernita Saylor stated the motion, seconded by Jeff Ommert to approve the lowest bid from IES Commercial to install the breaker

at the North Substation at a cost of \$29,810.00. On roll call vote Jeff Ommert, Tony Groshong, Vernita Saylor, Derek Raburn and Keith Luedders voted yes, none voted no and Tom McCarville was absent and not voting. Motion carried unanimously by City Council Members present. Dave presented a proposal from ODISS Enterprises to install an overhead door in the equipment shed south of the Casey's Store in the amount of \$3,950.00. Tony Groshong stated the motion, seconded by Derek Raburn, to approve a proposal from ODISS Enterprises to install an overhead door in the equipment shed south of the Casey's Store in the amount of \$3,950.00. On roll call vote Tony Groshong, Vernita Saylor, Derek Raburn, Keith Luedders, and Jeff Ommert voted yes, none voted no, and Tom McCarville was absent and not voting. Motion carried unanimously by City Council Members present.

City Clerk/Treasurer Report – Kandra Kinne asked the City Council if they wanted to move forward with the abatement of the Weaver trailer or wait until spring. The City Council decided to move forward with the removal. Kandra would contact West Central Nebraska Development District. The City has received an application for liquor license from Corner Café and the hearing will be on the agenda for the next meeting. The City has received notice that there will be a Nebraska Tax Advantage refund in October 2018 in the amount of \$5,550.21. Line Loss for November 1, 2017 billing is 1.40% fiscal year average for electric and 11.43% fiscal year average for water. The City has received the Revenue Sufficiency Review of the Municipal Electric rates. The proposed rates will increase current rates by 5%. The rates have not been reviewed since 2012. The City Council looked at the condition of the City's holiday lights. The cost to replace the existing lights is about \$600 to \$700 per fixture. The City has about 32 poles on the highway.

Public Comment – First Central Bank Staff Members Vernita Saylor and Jeff Ommert presented a check to Mayor Harpst for a donation to the City for carpet replacement in the meeting room. First Central Bank staff expressed their thanks to the City for the support First Central Bank received after their fire.
