1. APPROVAL OF MINUTES of July 14, 2021:

2. SITE PLAN & LAND USE PERMIT APPLICATIONS/FLOOD PLAIN DEVELOPMENT PERMITS:

- A. Flammang Family Trust at 808 Parker Street for an addition. Members reviewed the application and determined that the plan submitted is over the 45 percent for impervious property. Jason Weiss stated the motion, seconded by Jason Cobb, to deny the application for Flammang Family Trust for an addition at 808 Parker Street. Voting yes to deny were Jason Cobb, Jason Weiss and Vicki Brown. Debbi Runner and Mike Smith were absent and not voting. Motion carried unanimously by Planning Commission members present.
- B. Andrew Benson to construct a new home at 40309 Harvest Drive. Jason Cobb noted that the ownership of the property has been transferred. Jason Weiss stated the motion, seconded by Vicki Brown, to approve the Site Plan and Land Use Permit Application of Andrew Benson to construct a new home at 40309 Harvest Drive. - C. Shane Hannah of 311 Neville for new windows, sliding door, deck, and sidewalk.
